

“GROUPLOVE TOUR” COMPETITION

HOW TO ENTER

1. In order to enter the “Grouplove Tour” Competition (the “Competition”) individuals must purchase a ticket to any Grouplove concert listed on www.secret-sounds.com.au (the “Website”) via any of the authorised ticketing outlets listed on that same Website, by 23:59 AEDST on 30/11/2011.

2. Terms and Conditions together with all other information provided prior to entering the Competition form part of the rules of entering the Competition. Instructions on how to enter the Competition form part of these Terms and Conditions. Participation in this Competition is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
3. Entry is only open to Australian residents eighteen (18) years of age and over. Employees (and their immediate families) of the Promoter, participating retailers and agencies associated with this Competition are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

The panel’s decision is final and binding upon all entrants and no correspondence will be entered into.

Referred to as the “Prize”.
8. The prize value is A\$100 (one hundred dollars). Total gift pool value is A\$100 (one hundred hundred dollars).
9. If the Prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize with a gift to the equal value and/or specification, subject to any written directions from a regulatory authority.
